HURRICANE MARIA EVACUEE UPDATE

Please help spread the word to evacuees who may be residing in New Jersey to register with FEMA for disaster assistance. In order to be eligible to receive the various disaster assistance services under FEMA's Individual Assistance (IA) Program, individuals must register with FEMA through the toll free number 1-800-621-3362 or by going to www.disasterassistance.gov. FEMA has extended the deadline for registration for the United States Virgin Islands to January 8, 2018 and for Puerto Rico until March 20, 2018.

FEMA EXPANDS PUBLIC ASSISTANCE ELIGIBILITY TO HOUSES OF WORSHIP

FEMA recently announced that private non-profit houses of worship are eligible for disaster assistance as community centers without regard to their secular or religious nature. These changes are effective for disasters declared on or after August 23, 2017. Under the Robert T. Stafford Disaster Relief and Emergency Assistance Act (Stafford Act), FEMA provides financial assistance, through its Public Assistance Program, to certain private non-profit (PNP) organizations for the repair or replacement of facilities damaged or destroyed by a major disaster. FEMA's changes now make houses of worship owned or operated by PNP organizations eligible applicants for this financial assistance.
